**ARTIST APPLICATION**

The producers of the *Stanwood Camano Arts Festivals* event worked together on similar shows the last couple years attracting over 9,600 visitors in 2017 to Historic Downtown Stanwood, WA. We anticipate the first *Summer Arts Jam* will bring well over 10,000 visitors in 2018. All types of handcrafted works are represented. Those working in either new or traditional styles are encouraged to participate. This show is a colorful and varied display of high quality, handmade crafts and artworks. Quality independent artists are fundamental to the success of the event.

**Requirements:**

Your completed application, \$20 non-refundable jury fee, three 4x6 photos of your work and one 4x6 photo of your booth (additional photos, application, & jury fee if your booth is shared...no more than 2 artists per shared booth...shared booth only requires 1 booth fee) must be submitted together by **June 10, 2018**. Late application considered with \$15 late fee. Your four pictures will allow the jury committee to evaluate your artwork to assure the variety of mediums to be featured during the festival.

**Liability/Insurance:** The *Stanwood Camano Arts Festivals* expect Artists to carry their own insurance.

**Fees:** (all fees are for the full 3-day event):

- \$200.00 for a 10x10 booth
- \$400.00 for a double booth (2 – 10x10 booths)
- \$20.00 Jury fee (nonrefundable).

## Artist/Vendor Rules and Regulations

### **Check-In, Set-Up, Breakdown:**

*Thursday, July 12<sup>th</sup>:* Artists and Vendors will check in and set up their booths at their designated time to check in, which will be emailed to you once accepted to the festival. Check in times will start at 5:00PM.

*Sunday, July 15<sup>th</sup>* Artist & Vendor breakdown will begin at 5:00PM and ends at 8:00PM so the streets of Stanwood can be re-opened at 8PM.

**We will NOT accept late check-in/set-up.**

Due to insurance regulations and for the safety of Stanwood merchants and all artists/vendors, roads will be blocked. No vehicles will be permitted within the event area after set-up on Thursday. After 5pm Sunday vehicles will be permitted for breakdown.

### **Booths & Fees:**

All single booths are set up in quads, each with two open sides. Booths are assigned by the *Stanwood Camano Arts Festivals* committee. Prior participation with *Stanwood Camano Arts Festivals* does not guarantee acceptance into the current festival. Artists/Vendors must store their merchandise at their own risk while the festival is closed. All booths must be attended during all open hours of the festival.

*Stanwood Camano Arts Festivals* provide only space for a booth, the booth and its contents are the responsibility of the vendor.

**This is a “rain or shine” event and registration is final.**

### **Exhibition Standards:**

All products sold by the Artist/Vendor must be handcrafted and consistent with the 4x6 photos submitted with the application. Photos must be representative of your work, craft, and what you will be selling. Your invitation to participate in *Summer Arts Jam* is decided by a jury based on your application and provided photos. **Commercial and imported items are NOT allowed.** *Stanwood Camano Arts Festivals* reserves the right to close any booth not adhering to these regulations.

### **Security/Liability:**

Booth structures and contents are the responsibility of the Artist/Vendor. By submitting this application all Artists/Vendors, release *Stanwood Camano Arts Festivals*, its agents and the City of Stanwood from any damages and be solely responsible for any liability they may incur while doing business at *Stanwood Camano Arts Festivals’ Summer Arts Jam*. The *Stanwood Camano Arts Festivals* encourage and expect Artists and Vendors to carry their

own insurance policy.

**Restrictions:**

- Artists/Vendors are not allowed to “rove” with their merchandise at any time.
- Artists/Vendors are not allowed to break down early or leave early.
- Artists/Vendors are responsible for the behavior of their associates, assistants, and children.
- No Alcoholic beverages, loud music, television, generators, smoking, hawking or pets.

**Parking:** Artists/Vendors are required to park in Vendor Parking Area ONLY.
